#### **Bayers Lake QEII Community Outpatient Centre**

As your Member of the Legislative Assembly, I have made it a priority to ensure the completion of the QEII Bayer's Lake Community Outpatient Centre remains on schedule and that the facility is properly staffed with the healthcare providers necessary to operate the facility when it opens this fall. We all know, the urgency of this facility opening on time and with a full complement of staff cannot be underestimated.

Expanding healthcare facilities is desperately needed, not only for the residents of Timberlea-Prospect but for residents of the greater Halifax Regional Municipality who are unable to access the care they need to stay healthy. The QEII Bayer's

Lake Community Outpatient Centre is a much-needed addition to the healthcare infrastructure of HRM, and its completion is crucial to improving access to essential medical services for those who need it most.

I am proud to say that advocating for the approval of the Bayers Lake QEII Outpatient Center and securing its location in Timberlea-Prospect was accomplished back in 2017. Since then, the construction of the facility has been progressing steadily, with several important milestones set to be achieved in the coming months.



The first milestone is the substantia completion of the facility, which is expected to take place in August of this year. This means that the building will be ready for occupancy and the necessary equipment and furniture will be installed.

The second milestone is the occupancy

of the facility, which is set to take place in November 2023. At this point, the facility will be fully staffed with healthcare providers and open to the public.



The final milestone is the final completion of the facility, which is expected to take place in the Winter/ Spring of 2024.

I am pleased to report that an additional \$33.2 million dollars has been allocated for construction completion. Investing in this infrastructure will bring outpatient services, including cancer care, diagnostic imaging, rehabilitation services, primary care, and mental health and addictions services close to home for many, especially for Timberlea-Prospect residents.

The completion of the QEII Bayer's Lake Community Outpatient Centre is significant for our communities, and I am proud to have played a part in its realization. The BLOC will improve access to essential medical services for residents of the HRM, create jobs, and stimulate economic growth. I look forward to the successful opening and operation of this much-needed facility.

### **Transportation**

As the MLA representing one of the municipality's fastest-growing regions, my work has been centered on enhancing infrastructure and services for our community. This is crucial to accommodate the increasing number of people, housing, traffic, and commercial growth in the area. Here are some updates on this work:



#### Timberlea Village **Parkway**

Signal light installation work at the Timberlea Village Parkway and Saint Margaret's Bay Road intersection will begin in 2024. After inquiries from my office and local residents. HRM reviewed the Timberlea Village Parkway, including the intersections of Brunello Blyd and Maple Grove Ave. and Marketway Lane and Amalfi Way. They concluded traffic volumes do not warrant a crosswalk with flashers.

There are traffic controls planned for these intersections, the timing will be determined as the various phases of development are completed. I have met with the developer to ask that this be expedited and HRM is working with them on these plans.



#### **Prospect Road**

I am pleased to report that Prospect Road will finally be repayed from Evergreen Place all the way to St Margarets Bay Road this year during the provincial construction season.

This much-needed improvement will enhance both the safety and overall driving experience for all those who travel this route regularly.

As more information becomes available about the start date of construction. I will be sure to share it through my e-newsletter, so stay tuned for updates.



#### Highway 103

There has been some patching along Highway 103 in targeted areas during the month of May. The following is a current schedule of repaving my office worked together with Public Works staff to get approved within the capital

2024-25: Inbound to Halifax. Exit 3 easterly to the Beechville CNR Overpass

easterly to Exit 3 2028-29: Outbound from Halifax. Exit 3 easterly to the Beechville CNR Overpass.


Thanks to those involved in this decadelong effort from our communities, especially St. Margarets Stewardship Association and the Ecology Action Centre. Let's make it happen!

While it was disappointing to learn about the latest delay to rebuilding the BLT Community Centre, the province remains committed to providing funding for the project. I was anticipating the tender to be released this spring, however HRM Council deferred the construction phase of the project for one
